## THE ACTIVITIES

As an academic Brussels-based research centre and university faculty, the JMCE's goal is to provide cutting-edge research and teaching, as well as to stage events and create knowledge platforms in European Union studies

During the 2022-2025 period, the JMCE will host 18 research seminars, public conferences and lectures, 13 policy-oriented conferences and one Ph.D. workshop. The centre will provide lectures to undergraduate and graduate students on the Un-Muting power of the European Union. The JMCE will also offer research mobility grants to promote interactions between the JMCE and foreign universities by funding short-term visits for researchers from all over the world.

#### The JMCE activities concentrate on five major challenges:

- Safeguarding the rule of law
- · Ensuring inclusiveness
- Preserving the climate and natural resources
- Fostering a digital future for Europe
- Strengthening democracy.

Overall, the JMCE will offer a venue for EU studies and broaden the visibility of, interest in, and understanding of the European Union while building long lasting partnerships.





## **TEACHING**

The Institute for European Studies organizes various educational and training programmes in European Union studies at graduate, post-graduate, doctoral and post-doctoral levels, with master's courses given in French and/or English. True to the tradition of interdisciplinarity that characterizes USL-B, the IES offers its students an environment that blends approaches specific to law, economics, political science, history, and philosophy.

In the framework of the IES' Master's and Advanced Master's in European Studies, the aim of the Jean Monnet Centre of Excellence is to raise students' awareness of the EU's un-muting power. Findings from research activities, such as research seminars and academic conferences and workshops, will give rise to lectures by the EUNMUTE team members, and will also be made available to the academic community, practitioners, decision-makers, and civil servants of the European institutions and diplomatic circles teaching in our master's programmes.

The JMCE will develop original and innovative pedagogical activities aiming to involve students in a collective reflection on EUNMUTE issues. It will also foster a fruitful dialogue between master's students, policymakers and civil society actors.

## MULTIMEDIA TEACHING MATERIAL

The EUNMUTE team will produce teaching material in the form of five pedagogical videos per year. The video series will consist of short videos and/or podcasts on issues related to the EU's un-muting role regarding the five key challenges at the core of the project. Each video or podcast will address one specific challenge. All videos will be made available to students on the EUNMUTE JMCE's Youtube channel, as well as to a wider audience.

## PRACTICAL DIGITAL EXERCISE

In the context of specific courses taught in the Master's in European Studies, students are required to create, to review and to edit Wikipedia pages on topics related to the un-muting power of the EU. The aim of this activity is to have students contribute to improving public information on the subject, while simultaneously strengthening their own writing and reasoning skills (mastering of language, editing, peer reviewing by experts, etc.). This innovative teaching activity focuses on one of the five key challenges identified in the EUNMUTE project, namely EU social and economic inclusiveness.

## FAUSTA DESHORMES LA VALLE PRIZES

Each year, the JMCE will award two *Fausta Deshormes La Valle* prizes for the best research paper and master's thesis on the un-muting power of the European Union. One prize will be awarded to an undergraduate student and another to a graduate student enrolled in one of the IES master's programmes.

This prize was named after *Fausta Deshormes La Valle*, an Italian journalist who joined the European Commission in 1961 and dedicated most of her career in the Press and Information Service to raising awareness among and mobilizing young people and women in favour of European integration. She was a pioneer who worked tirelessly to give a voice to the voiceless.

## Ph.D. WORKSHOP

By the end of 2024, a two-day Ph.D. workshop on EU unmuting power will be held in Brussels. The workshop will offer an opportunity for Ph.D. students to present and discuss research related to the EUNMUTE issues. Ph.D. students, selected following a call for contributions, will be invited to present their research to an interdisciplinary set of academics from the JMCE and beyond. This event will help students improve their research and develop networks of researchers and academics from diverse backgrounds and different levels of experience.

The Ph.D. workshop will welcome submissions from Ph.D. students worldwide. To facilitate participation of students from low- and middle-income countries, the JMCE will offer up to five Travel Grants to cover travel and accomodation expenses.



## RESEARCH



#### **EUNMUTE RESEARCH SEMINARS SERIES**

The research seminar series provides an interdisciplinary platform centred on law, political science, political theory, and sociology. It aims to foster an academic conversation between the JMCE team members and the broader national and international scientific community. Each seminar tackles a specific topic related to EUNMUTE, and benefits from the insights of external speakers and discussants.

Six seminars are organized each year in a hybrid meeting format, with some of the audience joining remotely. Through audio and video conferencing technology, the seminar series reaches an audience beyond the university campus. Recordings of the seminars are publicly available online on the EUNMUTE YouTube channel and website.

#### **ACADEMIC WORKSHOPS**

In 2025, an academic workshop will aim to take stock of the research carried out in the framework of the Jean Monnet Centre of Excellence.

Organized during the last semester of the project, the workshop will consist of a two-day international academic conference organized at UCLouvain Saint-Louis - Bruxelles and broadcast online. The workshop will be an opportunity for the EUNMUTE team to showcase the findings of their research. In addition to the EUNMUTE team members, speakers will be selected from among those who previously participated in the research seminar and through an international call for contributions.

EUNMUTE academic conclusions will be collected in an edited volume to be published in the "Idées d'Europe" book series.

#### **EUNMUTE ACADEMIC SHORT STAY GRANT**

The EUNMUTE Academic Short Stay Grant is a research mobility scheme that aims to promote interactions between the EUNMUTE Centre of Excellence and foreign universities by funding short-term visits. This mobility scheme supports research projects carried out in domains covered by EUNMUTE.

The EUNMUTE Academic Short Stay Grant is intended for junior and senior researchers who wish to stay IN or OUT for academic purposes for a period of up to three months. Grant for outgoing mobility supports researchers from USL-B interested in EU Studies and willing to collaborate with foreign research centres and universities abroad in research domains covered by the EUNMUTE project. Grant for incoming mobility supports foreign researchers interested in the EUNMUTE project and willing to visit the JMCE in order to collaborate with the EUNMUTE research team.

Depending on the length of the research stay, funding opportunities are up to 2,500 euros.

## **OUTREACH**

#### **CULTURAL EVENTS**

Building on past successful collaborations and existing networks in various cultural and artistic domains, the JMCE will organize two cultural events during the project, such as screenings of feature movies or documentaries, theatrical performances, exhibitions, etc. These cultural events are intended to extend the dialogue on EUNMUTE themes beyond academic circles.

EUNMUTE cultural events will bring together artists, academics, civil society actors, and the broader public. They will provide forums for identifying and discussing with the public and, eventually with the muted, outnumbered or voiceless actors themselves, specific challenges that arise in the European Union and how these might be addressed.

#### PUBLIC DEBATES ON THE EU UN-MUTING POWER

Twice a semester, the JMCE offers public debates on issues connected to the Un-Muting power of the EU. The goal of the EUNMUTE public debates is to develop reflection on the future of European integration and EU policies. These public debates bring together the European Policy Community, civil society actors and academics.

#### **PRIVACY CAMP**

Privacy Camp is an annual conference organized in Brussels and held in association with the Computer Privacy & Data Protection International Conference (CPDP). The event brings together digital rights advocates and activists, as well as academics and policymakers from across Europe and beyond to discuss the most pressing issues facing human rights online. For eleven years, Privacy Camp has aimed to grasp how digital technologies impact the life and fundamental rights of European and non-European citizens and foster multiple crises. Privacy Camp approaches the digital world critically and questions what it means to regulate digital technologies and infrastructures in our times.

Privacy Camp is jointly organized by the EDRi, a network of NGOs, experts, advocates and academics working to defend and advance digital rights across the continent, the interdisciplinary Research Group on Law, Science, Technology & Society of the Vrije Universiteit Law (VUBLSTS), Privacy Salon vzw and the Institute for European Studies at USL-B.



Over the lifetime of the grant, the EUNMUTE Centre of Excellence will actively support the organization of Privacy Camp.

## JEAN MONNET CHAIRS

In addition to the EUNMUTE Jean Monnet Centre of Excellence, two other Jean Monnet Chairs have been established at the IES USL-B for the period from 2022 to 2025: the EUGlobalGreen Chair and the EUGendering Chair.

#### **EUGLOBALGREEN**

EUGlobalGreen is a Jean Monnet Chair project on the environment, led by Prof. Amandine Orsini, and is part of a reflection on the global disturbances and transformations generated by human beings.

#### The objectives pursued by the chair:

- The objective of the Chair is to respond to the challenge of the Anthropocene
  by proposing an innovative and intensive programme of study that aims to
  encourage teaching and research excellence to address this very issue, by
  mobilizing European studies to reflect on global governance.
- Each year, the Chair dispenses 90 hours of teaching on the role of the European Union as a global player in environmental challenges. In parallel, the Chair develops a «EUGLOBALGREEN toolbox» including at least five case studies, four video clips, and four series of conferences (broadcast online).
- In addition to these annual teaching and research activities, produced in French and English, the Chair also includes an academic workshop and two international peer-reviewed publications including an edited book and a special issue in an academic journal.

#### **EUGENDERING**

The EUGendering Jean Monnet Chair, led by Prof. Sophie Jacquot, constitutes a multidisciplinary platform allowing researchers, students, policymakers, civil society, and the larger public to better understand the challenges linked to the establishment of a Union of gender equality, non-discrimination and diversity. It focuses on how the EU confronts these challenges, and how it could better tackle them.

#### The objectives pursued by the chair:

- To build on the flourishing, dynamic and innovative scholarship which
  is currently developing in the field of gender and the EU, and to close
  the gap between the analytical dynamism of this field and its underrepresentation in students' training and curricula;
- To address the democratic challenge of rising gender+ inequalities in a context where the COVID-19 crisis has dramatically increased these inequalities:
- To raise the political question of the polarization of gender+ equality issues and the impact of illiberal attacks on gender+ equality policies at the EU level.


